# President's Memo To All Latah AARP Members & Friends

It's been a long time since you've received a Latah AARP Membership Newsletter and an update of events & happenings in our area. Part of this is due to uncertainty and part to changing circumstances. A major decision was Not to engage in 'face to face' events for Latah AARP Board and members unless and until our health safety circumstances and situation in North Central Idaho improved. Sad to say, we are still in a 'time of uncertainty'. January saw incredible and dangerous rising case numbers due to the Covid Pandemic. The numbers improved greatly in February, but in March things changed - - again. We are Now in our third (or fourth) 'surge' of the Corona Virus with another version (mutation) of the virus. While the vaccine and two boosters have been most helpful (especially for seniors) the virus continues. Further, the largest percentages of hospitalizations and deaths are in the 'senior segment' of our population and we wish to proceed with great caution.

Based on the realities of the health situation in our area, we will not be meeting or participating in any 'in person' events till August 4 when we plan to hold our next 'in person' Latah AARP Board meeting. That will be followed by two events - - a public meeting with our Idaho AARP Executive Council on September 6 and a regular member meeting September 23. You will receive more details about these events later. Do you

have a suggestion for a speaker or topic for the September 23 meeting? Both events are based on the assumption there will be no serious and/or adverse developments in the interim. We hope our situation will continue to improve, people will get vaccinated, and all will take reasonable precautions to avoid becoming ill.

In the meantime, there is some 'news' to be reported. Vice President Rhonda Comstock presented at the April 1 UI Financial Conference on behalf of AARP. She did a great job. Perhaps some of you were able to attend? Tax Aide volunteers provided information and assisted with tax return preparation in March and April at the 1912 Center. Dozens and dozens of people received assistance. Thank you to those volunteers. And, you have the opportunity to participate in a Telephone Town Hall with Sen. Mike Crapo on May 24. Details are elsewhere in this Newsletter. Thank you Idaho AARP Director Lupe Wissel for arranging this event.

We are continuing to ask for **volunteers** to serve on our *Latah AARP Chapter Board* and as officers. If you might be interested, please contact me or any other officer or board member. We will be happy to provide you with information and attempt to answer your questions. And, you are invited to attend our August 4 Board Meeting - - time & place to be decided later.

# An important letter many of us have received from AMAZON regarding Scammers

We want to help protect you from scammers that attempt to impersonate Amazon. Remember these important clues so that you can identify scams and keep your account and information safe:

- 1. Never feel pressured to give information (such as your credit card number or account password) over the phone, especially if the call was unexpected. Scammers may try to use calls, texts, and emails to impersonate Amazon customer service. If you're ever unsure, it's safest to end the call/chat and reach out directly to customer support through the Amazon app or website.
- Never pay over the phone. Amazon will never ask you to provide payment information, including gift cards (or "verification cards", as some scammers call them) for products or services over the phone.
- Trust Amazon-owned channels.
   Always go through the Amazon mobile app or website when seeking customer support or when looking to make changes to your account.
- 4. Be wary of false urgency. Scammers may try to create a sense of urgency to persuade you to do what they're asking. Be wary any time someone tries to convince you that you must act now.

## Will I get an auto insurance discount and/or a reduction in points for completing the course online?

The AARP Smart Driver™ online course is recognized as an approved accident prevention course for all drivers by the Idaho Transportation Department. By enrolling in this course, drivers of all ages may receive a three-point reduction from their driving record every three years or insured drivers age 55 and older may be eligible for an appropriate reduction in automobile insurance premium charges after completing this course. Please check with your insurance company or agent for any additional requirements for eligibility.
