March 31, 2007

President Shane Minden called the meeting to order at 1:10 p.m.

The minutes were read and approved.

Treasurer's Report: Checking currently has \$1865.59, Savings has \$1,726.22. We needed to purchase new checks, which were \$29.25. Our account is still based out of Wells Fargo. Kim McLaughlin presented a bill of \$34.55 for postage and copies; Gary Haberstad motioned to pay the bill, seconded by Myra Metcalf. A vote was taken and passed.

New Business:

Myra brought up the fact that ISCA is not incorporated. The cost would be \$100.00. She has already spoken to an Attorney, and has the paperwork all ready to sign and approve. The purpose for incorporation is to protect your officers and board from being sued. Discussion ensued about us never becoming incorporated in the past, as we require all clubs hosting the State show to be incorporated. A question arose that if we became incorporated, does that make all clubs that join us automatically incorporated. Kandi Hogsett explained that we are our own entity and the incorporation would just cover us. Kandi Hogsett motioned, seconded by Jodie Perkins for ISCA to become incorporated. A vote was taken and passed.

Anita Falen, our Historian is trying to gather information of State History. If anyone has anything you would be willing to share with her it would be appreciated.

KCSC asked that a 1-year ground rule be given to change the points system for the 2007 show. Points will be as follows: 10 points for 1st thru to 1 point for 10th. A vote was taken and approved.

Awards were shown that KCSC would like to give at the 2007 state show; a vote was taken and approved.

Kenny Moore shared a poster for a Junior Rodeo Clinic for the Drivers at Kootenai County Fairgrounds, Saturday May 5th. A Junior Rodeo will follow the clinic. (EWJRA Benefit Rodeo)

Visiting Royalty gave announcements on all of their upcoming events.

A talent show was performed by all Royalty from across the State.
