ISCA Winter Meeting Minutes February 9, 2008

President Shane Minden called the meeting to order at 1:29 p.m. at the Jack in the Box in Moscow, Idaho.

Last minutes were read by Kim McLaughlin and approved.

Treasurer's Report:

Myra reported Savings holds \$2,321.60 and Checking holds \$821.04 as of January 28th. A couple of clubs have not paid their \$1.00 fee. Myra also requested information on CIRA which no one knew. Our incorporation ended up being only \$30.00. Kim presented receipts for \$51.50 for Stamps and copies. Larry Weinman motioned to pay the bills, seconded by Kenny Moore, voted and passed.

Old Business:

Shane commented that a thank you to KCSC was overlooked at the 07 O-Mok-See and wanted to mention the job well done.

New Business:

Proposals for rule changes were voted on at this time (Please see attached sheet for result information).

Bids for 08 O-Mok-See: Cayuse Kids represented by Brad and Duane Minden have a tentative bid to host. They must return to their general membership meeting for support and approval. If approved they will host in Princeton on June 28th and 29th. Help was offered by all officers and members and we will encourage all clubs to pitch in financially so it will not be such a burden to raise money for awards. Brad will let Shane know the result of their clubs vote.

Raffle: Myra reported that with the \$350.00 we paid for signs our profit was only \$149.00. Myra wants to pay less for raffle product and show product or a picture of it at Spring Round-Up, Myra proposed we purchase 2 items for a maximum of \$125.00 from Craig Wicks for Raffle of which 30% goes to Royalty, and 70% to ISCA. Myra will take over trying to raise money for raffle. Including making tickets and having them at the Spring Round-Up ready to distribute. Motion seconded by Kenny Moore, a vote was taken and passed.

Kim McLaughlin shared information on a new Barrel & Pole Series that will be hosted by KCSC this year. This will hopefully include a Bikini Barrel Race as a fund raiser. This race will have \$1,000 added money. For more info talk to Kim McLaughlin.

Myra questioned if we can cut Royalty checks for girls now instead of at Spring Round-Up as the Queens crown has already been passed to current Queen. All clubs have not paid yet, however Kenny Moore motioned to pay the girls all monies which would be available as if all clubs were paid. This would amount to \$100.00 per girl, totaling \$300.00. Myra seconded motion, voted and passed.

Anita Falen commented on our records from 95 & 98. Timers only went to the hundredths, & Del

Rae Stevens had a record listed to the thousandths. Maridean Weinmann will try to contact Lenny Stevens to clarify.

New Officers for 2008:

President: Myra Metcalf nominated Shane Minden seconded by Kim McLaughlin. Myra motioned that nominations cease and a unanimous ballot be cast. Seconded by Kim. Congrats to Shane Minden

1st Vice President: After a couple nominations, and a couple declines, Myra Metcalf nominated David Limesand who was not present but had indicated to Myra he would hold the position if voted in. Seconded by Larry Weinmann. No other nominations, a vote was taken and passed. Congrats to David Limesand

2nd Vice President: Kenny Moore nominated Brad Minden who declined, Myra Metcalf nominated Vicki Pennington, seconded by Larry Weinmann. Brad Minden made motion that nominations cease and a unanimous ballot be cast, seconded by Kenny Moore. Vote taken and passed. Congrats to Vicki Pennington

Secretary: Shane Minden made a motion to cast a unanimous ballot for Kim McLaughlin, seconded by Larry Weinmann. Voted and Passed Congrats Kim

Treasurer: Larry Weinmann motioned to nominate Myra Metcalf. Brad Minden motioned to cease nominations and cast a unanimous ballot. Seconded by Larry Weinmann. A vote was taken and passed.


